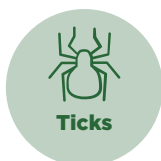
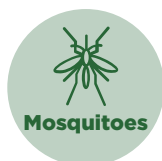

## Directions for Use:

Read and follow all directions and precautions on this product label.

Hold container 6 to 8 inches from skin and spray with a slow sweeping motion. Do not apply over cuts, wounds, irritated or sunburned skin. Do not spray in enclosed areas. Use just enough repellent to cover exposed skin. Do not use under clothing. Avoid over-application of this product.

Frequent reapplication and saturation are unnecessary. Apply sparingly around ears. When using on children, apply to your own hands and then put it on the child. Do not allow children to handle this product. After returning indoors, wash treated skin with soap and water.

For maximum protection, spread evenly with hands to moisten all exposed skin.

## To apply to face:

Spray palm of hand first and then apply sparingly and avoid eyes. Do not spray directly onto face. Do not apply near eyes and mouth. Will not damage fabrics including activewear, plastics, watch crystals, and painted or varnished surfaces. If using with sunscreen, apply sunscreen first, allow it to dry then apply insect repellent.
