The Government/Education segment generally consists of two focus areas:

Non-Federal Government – This tends to be a shorter selling cycle, and includes:

- State and local agencies
- City and county agencies
- Education (K-12) and higher education
- Non-profit agencies, religious organizations
- Native American tribes and related businesses (casinos)

**Federal Government** – This is a longer selling cycle, and includes areas like:

- The federal government and its agencies (e.g., Dept. of Defense, Dept. of Transportation, VA, USPS, Federal Reserve and TSA)
- Branches of legislative government
- Secret Service
- IRS
- All branches of military






